

And More...

- Donors can use an **IRA or other retirement asset** such as a 401(k), Keogh, or 403(b) naming Recovery International as the beneficiary, to establish a new fund or contribute to an existing fund.
- **Real estate**, including homes or other property, may be given to Recovery International at its current market value, allowing the donor to receive a full charitable deduction and avoid capital gains tax on the appreciation. Real estate may also be passed to Recovery International upon death.
- **Endowment Funds** can be established to ensure the longevity of a gift to Recovery International.
- **Other ways to donate** include:
 - Transfers from an existing private foundation
 - Charitable Remainder Trusts
 - Charitable Gift Annuities
 - Charitable Lead Trusts.

For considering a gift to Recovery International. By providing support to RI, you help to ensure the longevity of the organization, making sure it is here for decades more for those who need and benefit from it.

Recovery International is a 501(c)(3) non-profit organization, founded in 1937 by Dr. Abraham Low and his patients. Donations are tax deductible to the full extent allowed by law. Our Tax ID Number is 36-2041667.

Recovery International has various fundraising and membership campaigns throughout the year.

Membership in RI is a way to support the organization and receive some additional benefits in appreciation. Membership options begin at \$40. Our top tier of membership is the lifetime membership at \$1,000. Besides the extra benefits lifetime memberships provide, they are convenient as you no longer need to renew your membership annually.

Annual or year-end **giving campaigns** are when we reach out to RI participants past and present seeking support.

Giving Tuesday, the Tuesday after Thanksgiving, is a worldwide movement asking people to support their favorite non-profits.

Ways to Give

- **Online donations** can be made securely through our website. If you sign into your RI (Neon) account first, the donation will be immediately credited to your account. *If you forget your login information, no worries; we will do our best to locate your account and record the donation there.*
- **Recurring online donations** can be arranged through our website, donating a fixed amount regularly. You can set it and forget it!
- **Checks** can be mailed to our office in Oak Brook, or can be brought to in-person community meetings. Checks should be made payable to *Recovery International*.
- **Cash** donations can be made at in-person community meetings.
- To make **a donation in memory or honor of someone**, simply choose that designation on the website when you make the donation, or include a note with your check.

More Ways to Give

About The Society of Dear Ones

- Including Recovery International in your **estate plan or will** can significantly reduce the estate taxes otherwise payable at death. (Please consult with your attorney to discuss the specifics of your situation.) It also ensures a lasting legacy that can provide support to others who will benefit from the RI Method. People who have told RI that they intend to include RI in their estate plan are considered members of Dr. Low's *Society of Dear Ones*, and receive special recognition and appreciation.
- **Life insurance** can be used to create a major gift for Recovery International in one of two ways. First, the donor can transfer ownership of a policy to RI and receive a current income tax deduction in the year the transfer is made. Second, the donor, while retaining ownership of the policy, can name Recovery International as a beneficiary of the policy.
- Appreciated **stocks and bonds** may be given to Recovery International, allowing donors to deduct their current market value as a charitable contribution and avoid capital gains tax on the appreciation.
